

"Once you find a person in the database, you can click on various links to display that person's pedigree chart, descendants chart, a fan chart, a timeline chart, and more." The United States Citizenship and Immigration Service (USCIS) have a Genealogy Notebook on their website which you may find of interest. The genealogy notebook is a place for the USCIS Genealogy Program to share answers to commonly asked Genealogy research and record questions. You can submit a question by writing to: <u>Genealogy.USCIS@uscis.dhs.gov</u>. The current genealogy notebook question refers to C-files. C-files are document naturalizations - the acquisition of United States citizenship after birth. C-Files contain copies of records evidencing the: Granting of naturalized U.S. citizenship by courts between from 1906 to 1956; and Issuance of Certificates of Citizenship to those who derived or resumed U.S. citizenship.
